ARTICLE I - NAME

The name of this corporation is JC LANDSCAPING SERVICES, INC.

ARTICLE II - PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business.

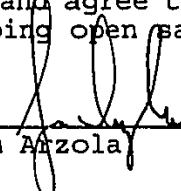
