

## ARTICLES OF INCORPORATION OF ACCESS INFORMATION TECHNOLOGIES, INC.



FIRST: The name of the corporation (the "Corporation") is ACCESS INFORMATION TECHNOLOGIES, INC.

SECOND: The principal office of the Corporation is 5020 Tamiami Trail North, Suite 200, Naples, Florida 34103.
