ARTICLES OF AMENDMENT OF THE ARTICLES OF INCORPORATION OF R 23

TALLA AM 9:31

TOMLIN INC., a corporation organized and existing under the real laws of the State of Florida (the "Corporation"), in order to amend its Articles of Incorporation in accordance with the requirements of Chapters 607 and 621, Florida Statutes, does hereby certify as follows:

- 1. The Articles of Incorporation of the Corporation were filed by the Secretary of State of the State of Florida on January 14, 1997.
- 2. The Amendment to the existing Articles of Incorporation being effected hereby is that resulting from completely deleting Article III of the Articles of Incorporation as of the date hereof, and substituting in its place the Article set forth below.

As amended below, Article III of the Articles of Incorporation has the sole effect of changing the number of shares of stock that the Corporation is authorized to have outstanding at any one time.
