Name

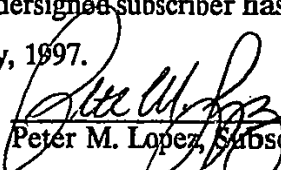

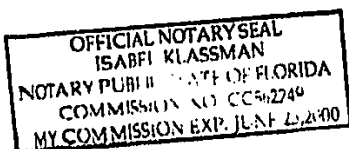
