ARTICLES OF INCORPORATION OF GAECOM CORPORATION

THE UNDERSIGNED, have executed the following documents as incorporator of the above named corporation, a corporation organized under the law of the State of Florida, and all rights, duties and obligations of the undersigned incorporators, and those of the corporation, are to be determined with the laws of the State of Florida.

ARTICLE I

The name of the corporation shall be:

To purchase, take, receive, issue, or otherwise acquire, own, hold, improve, use and otherwise deal in with real or personal property or any interest therein, wherever situated;

To sell, convey, mortgage, pledge, created a security interest in, lease, exchange, transfer and otherwise dispose of all and any part of its properties and assets;

To lend money to, and use its credit to assist its officers and employees in accordance with Florida Statute #607.141
