**ARTICLES OF INCORPORATION**

The undersigned Incorporator hereby forms a corporation under the laws of the State of Florida:

**ARTICLE I. CORPORATE NAME**

The name of this Corporation is:

**Quality Oncology of Ocala, Inc.**

**ARTICLE II. MAILING ADDRESS OF CORPORATION**

The mailing address of this Corporation is: 1200 S. Pine Island Road, Suite 170, Plantation, Florida 33324.

**ARTICLE III. CAPITAL STOCK**

The aggregate number of shares of stock that this Corporation is authorized to issue and have outstanding at any one time is one hundred thousand (100,000) shares of common stock having a par value of \$.001 per share. The Board of Directors of this Corporation shall have the power to divide and issue the common stock into one or more series and to determine the limitation and relative rights of each such series, consistent with the laws of the State of Florida. Shares of one series may be issued as a share dividend in respect of shares of another series.

**ARTICLE IV. TERM OF EXISTENCE**

This Corporation shall have perpetual existence.

**ARTICLE V. INITIAL REGISTERED OFFICE AND REGISTERED AGENT**

The street address of the initial registered office of this Corporation in the State of Florida and the Corporation's initial registered agent at that office shall be: KTG&S Registered Agent Corporation, 100 S.E. 2nd Street, 28th Floor, Miami, Florida 33131.

**ARTICLE VI. BOARD OF DIRECTORS**

The number of members of the Board of Directors may be increased or decreased from time to time as provided in the Bylaws, but shall never be less than one (1).

**ARTICLE VII. INCORPORATOR**

The name and street address of the person signing these Articles of Incorporation as the Incorporator is: KTG&S Registered Agent Corporation, 100 S.E. 2nd Street, 28th Floor Miami, Florida 33131.

**ARTICLE VIII. AMENDMENT**




