ARTICLES OF INCORPORATION
OF
SPORTS DEVELOPMENT CORP.

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following articles of incorporation:

ARTICLE ONE

The name of this corporation is Sports Development Corp.

ARTICLE TWO

The corporation is to have perpetual existence.

ARTICLE THREE

The corporation may transact any and all lawful business for which corporations may be incorporated under the Florida Business Corporation Act.

ARTICLE FOUR

4.01 The shares of capital stock of this Corporation, all of which shall be fully paid and non-assessable, shall consist of two thousand (2,000) shares of common stock of a par value of One (\$1.00) Dollar. The authorized shares of common stock shall be divided into two equal classes of 1,000 shares each: Class A and Class B which shall have equal rights to dividends and upon liquidation to liquidation proceeds. Class A shares shall have voting rights on all matters on which shareholders shall have a right to vote and Class B shares shall not have any voting rights on any matters. The capital stock in this Corporation may be issued by this Corporation as, when and for such considerations as may be fixed from time to time by the Board of Directors.

4.02 The minimum amount of paid-in capital with which the corporation shall begin business shall be not less than Five Hundred Dollars (\$500.00).

ARTICLE FIVE

5.01 The street address of the initial corporate office of the corporation is 1474 Via Privado, Jupiter, FL 33477.

5.02 The name and address of the initial Resident Agent for this corporation to accept service of process within the State of Florida is Mark J. Nowicki, 14155 U. S. Highway One, Suite 302, Juno Beach, Florida 33408.

ARTICLE SIX

6.02 Said incorporator is over the age of eighteen (18) years; is sui juris, and is a citizen of the United States.

ARTICLE SEVEN
