

OF PASQUE CORP.**

**ARTICLE I
CORPORATE NAME**

The name of this corporation shall be:

**ARTICLE II
DURATION**



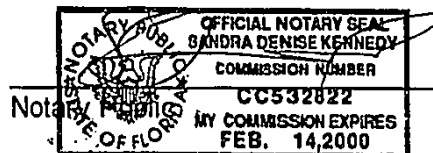


