ARTICLE I - NAME

The name of this Corporation is J.P.W., Inc., and the principal business address of the Corporation is 7969 Little Fox Lane, Jacksonville, Florida 32256.

ARTICLE II - COMMENCEMENT AND DURATION

Pursuant to Section 607.0203, Florida Statutes, this Corporation shall commence upon the date of execution of the Articles of Incorporation which is January 21, 1997 and shall be filed with the Secretary of State within 5 business days from said date. 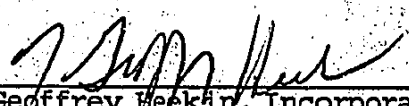
