The undersigned does hereby associate himself into a corporation under chapter 607 of the laws of the State of Florida and does hereby certify as follows:

The name of the Corporation is FEDERAL AMERICAN INSPECTIONS, INC., and the address of the principal office of this corporation shall be 2523 Marseilles Drive, Palm Beach Gardens, Florida 33410. The mailing address of the corporation shall be the same.

2. The corporation shall have perpetual existence.


