**ARTICLE I - CORPORATE NAME**

THE NAME OF THE CORPORATION IS EXPRESS SNACK SERVICES, CORP.

**ARTICLE II - DURATION**

THIS CORPORATION SHALL COMMENCE ON THE DAY OF FILING AND SHALL EXIST PERPETUALLY UNLESS DISSOLVED ACCORDING TO LAW.

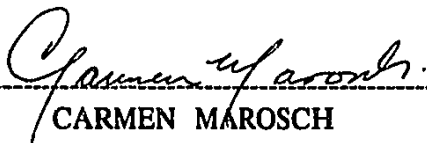
