**ARTICLES OF AMENDMENT
OF THE ARTICLES OF INCORPORATION OF
ONE STEP BILLING, INC.**

Pursuant to Sections 607.1003 and 607.1006 of the Florida Business Corporation Act, the Articles of Incorporation of ONE STEP BILLING, INC. (the "Corporation"); are hereby amended according to these Articles of Amendment:


FIRST: The name of the Corporation is ONE STEP BILLING, INC.

SECOND: Article I of the Articles of Incorporation is hereby deleted in its entirety and the following inserted in lieu thereof:

"The name of the Corporation is TARIFF INFORMATION SYSTEMS, INC.

THIRD: The foregoing amendment was adopted on August 27, 1998 by written consent of the sole shareholder and the board of directors of the Corporation, constituting a sufficient number of votes for the amendment to be approved in accordance with Florida Statutes and by the board of directors of the Corporation.
