ARTICLE I

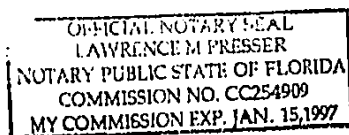


