ARTICLE I
CORPORATE NAME

The name of this corporation is Information Systems Consulting, Inc.

ARTICLE II
CORPORATE DURATION

The duration of the corporation is perpetual.

ARTICLE III
PURPOSE

The general purposes for which the corporation is organized are:

1. To engage in the business of consultation, service, and advice to clients in the field of information systems.
2. To transact any other lawful business for which corporations may be incorporated under the Florida General Corporation Act, or engage in any other trade or business which can, in the opinion of the Board of Directors of the corporation, be advantageously carried on in connection with or auxiliary to the foregoing business;
