#### ARTICLES OF INCORPORATION

## FOR

DEUTSCHE PROFESSIONAL PRINTING EQUIPMENT, INC.

I, the undersigned, being of legal age and a natural person, do hereby subscribe acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

## ARTICLE I

The name of this corporation shall be DEUTSCHE PROFESSIONAL PRINTING EQUIPMENT, INC.

## ARTICLE II

This corporation may engage in and transact any activity or business for which a corporation may be incorporated under the Florida General Corporation Act. The principal office address is at 13857 SW 158th Terrace, Miami, Florida 33177.

The total authorized stock of this corporation shall consist of 1,000 shares of common stock, par value \$1.00 per share.
