ARTICLES OF INCORPORATION OF DIALED IN COMMUNICATIONS

#### ARTICLE I

The name of this corporation shall be as follows: DIALED IN COMMUNICATIONS, INC., and the initial principal office of this Corporation shall be: 20801 BISCAYNE BOULEVARD, SUITE 424, AVENTURA, FLORIDA 33180.

#### ARTICLE II

The commencement of existence of the corporation shall be the date of filing.

# ARTICLE III

The general nature of the business and objects and purposes proposed to be transacted and carried on by this corporation are to do any and all of the things herein mentioned, as fully and to the same extent as natural persons might do, viz:
