The undersigned, desiring to form a professional corporation for the practice of chiropractic medicine, in accordance with Chapter 607, Corporations, and/or Chapter 621, Professional Service Corporations, of the Florida Statutes, does hereby adopt the following Articles of Incorporation:

**ARTICLE ONE
NAME**

The name of this corporation shall be **SCOTT A. RUBIN, D.C., P.A.**

**ARTICLE TWO
PRINCIPAL OFFICE**

The place in the State of Florida where the corporation's principal office is to be located is 1045 9th Avenue North, City of St. Petersburg, County of Pinellas.

**ARTICLE THREE
PURPOSES**

The purpose for which the corporation is organized is to primarily engage in the specific business of practicing chiropractic medicine as a professional association; to engage generally in the business of a chiropractic medical professional association as the same is now or hereafter defined by statute, rules and regulations, and in connection therewith to own property, to enter into contracts, and to transact any lawful business related thereto; to engage in such other business as may be authorized or permitted by Chapter 607, Corporations, and/or Chapter 621, Professional Service Corporations, of the Florida Statutes.

The duration of the corporation shall be perpetual.

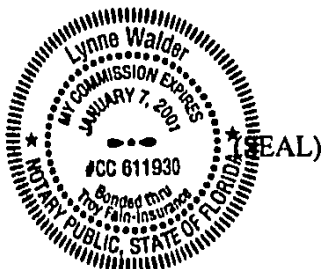


