The undersigned, for the purpose of forming a corporation under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation.

ARTICLE I - NAME AND OFFICE BUSINESS ADDRESS

The name of this corporation is VICTORY SERVICES, INC. The principal business and mailing address for the Corporation is 8201 G N. W. 74th Avenue, Miami, Florida 33166.

ARTICLE II - DURATION

This corporation shall exist in perpetuity.
