AMENDMENT**

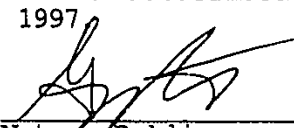

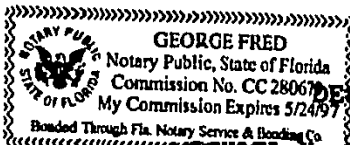
