ARTICLES OF INCORPORATION

OF

ELIZABETH A. FIX, P.A.
A Professional Association

The undersigned incorporator, for the purpose of forming a Professional Association under Florida's Professional Service Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I

The name and address of the Professional Association shall be:

ARTICLE II

The purpose for which the Professional Association is organized is to engage in the licensed practice of real estate sales under regulation of the Florida Department of Professional Regulation. All stock issued by this Professional Association shall be common voting stock of a single class. The number of shares of stock that this Professional Association is authorized to have outstanding at any time is 100 shares having a par value of \$ 1.00 per share.

The period of duration of the Professional Association is perpetual.
