KNOW ALL MEN BY THESE PRESENTS: That the undersigned incomparator does hereby incorporate a corporation under the provision of Chapter 607, Florida Statutes for the transaction of business with and under the following Articles of Incorporation:

ARTICLE I

The name of the corporation shall be and is <u>Cooke & Shorter Inc.</u> located at 5906 lona Ave., Orlando, Fl. 32835.

ARTICLE II

The duration of the corporation shall be and is perpetual, and the date and time of the commencement of the corporation's existence shall be and is January 16, 1997.

ARTICLE III

The general purposes for which the corporation is initially organized are as follows:

- A. Remodeling and refurbishing of buildings.
- B. Painting of buildings both exterior and interior.
- C. To transact any or all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes.
