The undersigned, acting as incorporator of Silver Nip Juice, Inc. under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE ONE - NAME

The name of the corporation is Silver Nip Juice, Inc.

ARTICLE TWO - PRINCIPAL OFFICE

The address of the principal office of the corporation is:

**ARTICLE THREE
COMMENCEMENT OF EXISTENCE**

The existence of the corporation will commence on the filing of the articles of incorporation.

ARTICLE FOUR - PURPOSE

The corporation is organized to engage in any activity or business permitted under the laws of the United States and Florida.

ARTICLE FIVE - CAPITAL STOCK

The number of shares of stock that this corporation is authorized to have outstanding at any one time is 10,000 shares of common stock having a par value of \$1.00 per share.

**ARTICLE SIX
INITIAL REGISTERED OFFICE AND AGENT**

The street address of the initial registered office of the corporation is 33 East Wall Street, Frostproof, FL 33843, and the name of the corporation's initial registered agent at that address is P. T. Wilson.

ARTICLE SEVEN - INITIAL BOARD OF DIRECTORS

The corporation shall have two directors initially. The number of directors may be either increased or diminished from time to time, as provided in the bylaws, but shall never be less than one. The names and street addresses of the initial directors are:

ARTICLE EIGHT - INCORPORATOR

The incorporator of the corporation assigns to this corporation his rights under Section 607.0201, Florida Statutes, to constitute a corporation, and he assigns to those persons designated by the board of directors any rights he may have as incorporator to acquire any of the capital stock of this corporation, this assignment becoming effective on the date corporate existence begins.

ARTICLE NINE - BYLAWS

The power to adopt, alter, amend, or repeal bylaws shall be vested in the board of directors and the shareholders, except that the board of directors may not amend or repeal

any bylaw adopted by the shareholders if the shareholders specifically provide that the bylaw is not subject to amendment or repeal by the directors.

ARTICLE TEN - AMENDMENTS

The corporation reserves the right to amend, alter, change, or repeal any provision in these Articles of Incorporation in the manner prescribed by law, and all rights conferred on shareholders are subject to this reservation.
