## **ARTICLES OF INCORPORATION**

The undersigned, acting as Incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

1. NAME. The name of the corporation is:

2. ADDRESS. The principal address of the corporation is:

- 3. **DURATION**. The period of its duration is perpetual.
