The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation shall be:

GALAXY COMPETITIONS, INC.

The address of the principal office of this corporation shall be 7512 Dr. Phillips Boulevard, Suite 50-310, Orlando, Florida 32819 and the mailing address of the corporation shall be the same.

ARTICLE II. NATURE OF BUSINESS
