#### ARTICLE I - NAME

The name of this corporation is: J.T. Restaurant Enterprises, Inc.

#### ARTICLE II - DURATION

These Articles of Incorporation shall become effective upon the date of their execution and acknowledgement, provided these Articles are filed by the Department of State within five (5) days of their signing and acknowledgement. #### ARTICLE III - GENERAL PURPOSES
