

# ARTICLES OF INCORPORATION

# **ARTICLE I - NAME**

The name of this corporation is LANDMARK REAL ESTATE, INC.

#### **ARTICLE II - DURATION**

This corporation shall have a perpetual existence commencing upon the filing of these Articles of Incorporation by the Department of State.
