### ARTICLES OF INCORPORATION

#### ARTICLE I

The name of this corporation is PTME, INC.. The principal office and/or mailing address of this corporation is as follows: 3816 Tamiami Trail, Port Charlotte, Florida 33952.

### ARTICLE II
