The undersigned subscriber to these ARTICLES OF INCORPORATION, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE 1. NAME

The name of the corporation shall be:

REDI CLEANERS, INC.

The principal place of business of this corporation shall be 10653 Wiles Road, Coral Springs, Florida 33076.

ARTICLE 11. NATURE OF BUSINESS

This corporation may engage or transact in any business or all lawful activities or business permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.

ARTICLE 111. CAPITAL STOCK

The number of shares of stock that this corporation is authorized to have outstanding at any one time is One Thousand shares of common stock having a par value of \$1.00 each.

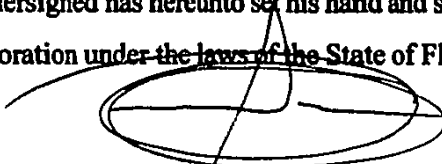

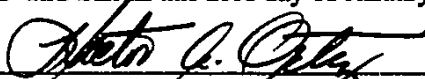

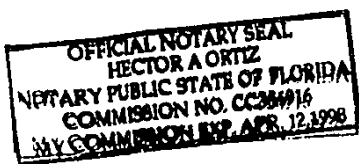
