The undersigned, a natural person of the age of eighteen years or over, desiring to form a corporation pursuant to the provisions of the Business Corporation Law of the State of Florida, hereby certifies as follows:

FIRST: The Name of the Corporation is: Concord Painting Inc.
(" The Corporation")

The purposes for which the Corporation is formed are to engage in any act or activity for which corporations may be organized under Florida Business Corporation Law; provided whoever, that the Corporation is not formed to engage in any act or activity requiring the consent or approval of any State official, department, board, agency or other body without first obtaining the consent of such body.
