**ARTICLES OF AMENDMENT TO
ARTICLES OF INCORPORATION OF
SEK INSTITUTIONAL COMMUNICATIONS, CORPORATION**

PURSUANT TO SECTION 607.1006, FLORIDA STATUTES, THIS FLORIDA PROFIT CORPORATION ADOPTS THE FOLLOWING ARTICLES OF AMENDMENT TO ITS ARTICLES OF INCORPORATION.

FIRST: Amendments adopted: Article III of the original Articles of Incorporation is deleted in its entirety and replaced with the following text:

ARTICLE III:

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 3,000,000 shares of common stock having a nominal or par value of One Dollar (\$1.00) per share. All said shares shall be payable in cash, property, labor or services at a valuation to be fixed by the Board of Directors at a meeting called for that purpose. Property, labor or services may be purchased or paid for with capital stock at a just valuation to be fixed by the Board of Directors.

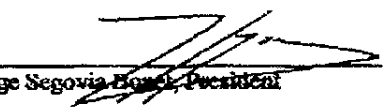
SECOND: That the existing shareholders shall have the same number of shares that they currently have issued to them.

THIRD: The foregoing amendments to the Articles of Incorporation of SEK INSTITUTIONAL COMMUNICATIONS, CORPORATION, were adopted as of the filing date hereof.

FORTH: The amendments were approved by the shareholders. The number of votes cast for the amendments by the shareholders was sufficient for approval.
