ARTICLES OF INCORPORATION

OF

THE TAN-TOO COMPANY INTERNATIONAL, INC.

Pursuant to the provisions of section 607.1006, Florida Statutes, this corporation adopts the following Articles of Amendments to its Articles of Incorporation:

FIRST:

Article 7.1 of the Articles of Incorporation provides:
