

**ARTICLE I**

The name of the Corporation is LOGA INTERNATIONAL CORP. (the "Corporation").

**ARTICLE II**

**ARTICLE III**

The Corporation shall have the authority to issue 1,000 shares of Common Stock, no par value.

**ARTICLE IV**

**ARTICLE V**

The Corporation may engage in any activity or business permitted under the laws of the State of Florida.


#### ARTICLE X

These Articles of Incorporation may be amended in the manner authorized by law at the time of amendment.


