ARTICLE I. NAME

The name of the corporation is BERT SMITH, C.P.A., CHARTERED

ARTICLE II. COMMENCEMENT AND DURATION

The existence of the corporation shall commence upon the filing of these Articles of Incorporation. This corporation's duration shall be perpetual.
