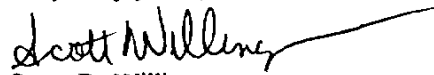
Greetings:

This office represents Legal Media Resources, Inc. Enclosed is an application for reinstatement along with a check in the amount of \$300.00 which represents filing fees for the year 1998 and 1999 respectively.

My client is requesting a waiver of the \$600.00 reinstatement fee based on the following facts. The corporation was incorporated on January 28, 1997. The next annual report filing was due in 1998. State of Florida records reflected an address for Legal Media Resources, Inc. at 19422 E. Country Club Drive, Aventura, Florida 33180. My client moved on or about October, 1997. There was a forwarding order in effect for one (1) year, which means that any documents sent to the old corporate address (19422 E. Country Club Drive) should have been forwarded until October, 1998.
