Pursuant to and in compliance with the provisions of Chapter 607, Florida Statutes, PISTILS & PETALS FARM DIRECT, INC., a Florida corporation (the "Corporation") adopts the following Amended and Restated Articles of Incorporation:

**ARTICLE I



ADOPTION OF AMENDMENTS**


