#### ARTICLES\_OF\_INCORPORATION

#### CONCEPTS USA, INCORPORATED

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

## Article I. Name.

The name of the Corporation is: Concepts USA, Inc.

#### Article II. Duration.

The duration of the Corporation is perpetual.

## Article III. Purpose.
