ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of this corporation is FROST & KENWORTHY, INC.

ARTICLE II - DURATION

This corporation shall exist perpetually.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of obtaining a liquor license, sale of alcoholic beverages, and for any other lawful purpose.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 7000 shares of \$1.00 per value common stock.

ARTICLE V - ADDRESS OF PRINCIPLE OFFICE
