ARTICLE I.

NAME

The name of this corporation is CEA EQUITY, INC.

ARTICLE II.

PRINCIPAL OFFICE

ARTICLE III.

DURATION: EFFECTIVE DATE

This corporation shall exist perpetually, commencing as of January 24, 1997.

BYLAWS




