ARTICLE I - NAME AND BUSINESS ADDRESS

The name of this Corporation is CTI of West Virginia, Inc. and its business mailing address is 4491 South State Road Seven, Suite 200, Ft. Lauderdale, Florida 33314.

ARTICLE II - DURATION

The Corporation shall have a perpetual existence.

ARTICLE III - PURPOSE

The purpose of this Corporation is to engage in any activities or business permitted under the Laws of the United States and Florida.

ARTICLE IV - CAPITAL STOCK

The maximum number of shares which this Corporation is authorized to have outstanding at any time is 10,000 shares of common stock having a par value of \$.01 per share.

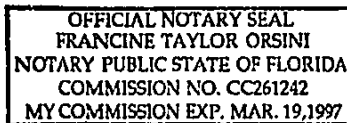
