1. Antolin Mendez is the President of MENDEZ MOBILE HOME SET-UP, INC., a Florida corporation, (hereinafter "Corporation").

2. That the Corporation was administratively dissolved by the Florida Department of State on September 21, 2001.

3. That the Corporation failed to file its 2001 and 2002 Annual Reports or pay the 2001 and 2002 Annual Report filing fees within the time prescribed by Florida Statutes Chapter 607, because:

3.1 the written notice and requirements for filing the Annual Report and pay the Annual Report fees to the Florida Department of State was never received by the Corporation; and,

6. No further ground or grounds exist for the administrative dissolution of the Corporation.
