Initial Board of Directors



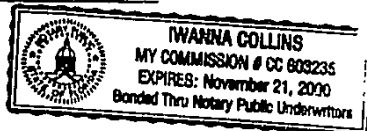
