ARTICLE I

NAME

THE NAME OF THIS CORPORATION IS ALESSANDRA V. BORNIA INC.

ARTICLE II

NATURE OF BUSINESS

THIS CORPORATION IS BEING FORMED FOR THE FOLLOWING PURPOSES:

TO CONDUCT ANY AND ALL BUSINESS ACTIVITIES PERMITTED BY THE LAWS OF THE STATE OF FLORIDA.

TO GENERALLY HAVE AND EXERCISE ALL POWERS, RIGHTS AND PRIVILEGES NECESSARY AND INCIDENT TO CARRYING OUT PROPERLY THE OBJECTS HEREIN MENTIONED.

TO CARRY ON ANY OTHER LAWFUL BUSINESS AND TO DO ANY AND EVERYTHING NECESSARY, SUITABLE, CONVENIENT OR PROPER FOR THE ACCOMPLISHMENT OF ANY OF THE PURPOSES OR THE ATTAINMENT OF ANY OR ALL OF THE OBJECTS HEREIN BEFORE ENUMERATED OR INCIDENTAL TO THE PURPOSES AND POWERS HEREIN NAMED OR FOR THE ENHANCEMENT OF THE VALUE OF THE PROPERTY OF THE CORPORATION OR WHICH AT ANY TIME APPEAR CONDUCIVE THERETO OR EXPEDIENT.

ARTICLE III

TERM OF EXISTENCE

THIS CORPORATION SHALL HAVE PERPETUAL EXISTENCE UNLESS SOONER DISSOLVED IN ACCORDANCE WITH THE LAWS OF THE STATE OF FLORIDA. THE DATE ON WHICH CORPORATE EXISTENCE SHALL BEGIN IS THE DATE ON WHICH THESE ARTICLES OF INCORPORATION ARE FILED WITH THE SECRETARY OF STATES OF THE STATE OF FLORIDA.

ARTICLE IV

CAPITAL STOCK

INITIAL BOARD OF DIRECTORS

THIS CORPORATION SHALL HAVE THREE DIRECTORS INITIALLY. THE NUMBER OF DIRECTORS MAY BE EITHER INCREASED OR DIMINISHED FROM TIME TO TIME BY THE BY-LAWS, BUT SHALL NEVER BE LESS THAN ONE (1).

ARTICLE VII

CLASSES OF DIRECTORS

THE BY-LAWS OF THIS CORPORATION MAY PROVIDE THAT THE DIRECTORS BE DIVIDED INTO TWO OR MORE CLASSES WHOSE TERMS OF OFFICE SHALL RESPECTIVELY EXPIRE AT DIFFERENT TIMES, PROVIDED THAT NO SUCH TERM SHALL CONTINUE LONGER THAN THREE (3) YEARS AND PROVIDED FURTHER THAT AT LEAST ONE FOURTH (1/4) IN NUMBER OF THE DIRECTORS SHALL BE ELECTED ANNUALLY.

FURTHER, THE POWER TO ADOPT, ALTER, AMEND OR REPEAL BY-LAWS SHALL BE VESTED IN THE BOARD OF DIRECTORS AND THE SHAREHOLDERS OF THIS CORPORATION.

ARTICLE IX

POWERS

THIS CORPORATION SHALL HAVE ALL OF THE CORPORATE POWERS ENUMERATED IN THE FLORIDA CORPORATION ACT.

ARTICLE X

DIVIDENDS

DIVIDENDS PAYABLE IN SHARES OF ANY CLASS MAY BE PAID TO THE HOLDERS OF SHARES OF ANY OTHER CLASS.

ARTICLE XI

INDEMNIFICATION

THIS CORPORATION SHALL INDEMNIFY ANY AND ALL OF ITS DIRECTORS, OFFICERS, EMPLOYEES OR AGENTS OR FORMER DIRECTORS, OFFICERS, EMPLOYEES, OR AGENTS OR ANY PERSON OR PERSONS WHO MAY HAVE SERVED AT ITS REQUEST, AS A DIRECTOR, OFFICER, EMPLOYEE OR AGENT OF ANOTHER CORPORATION PARTNERSHIP, JOINT VENTURE, TRUST OR OTHER ENTERPRISE IN WHICH IT OWNS SHARES OF CAPITAL STOCK OR OF WHICH IT IS A CREDITOR, TO THE FULL EXTENT PERMITTED BY LAW.
