THE UNDERSIGNED, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE 1

NAME

The name of this corporation is David Clark Properties, Inc. The principal place of business is 4665 Bohemia Place, Pensacola, Florida 32504.

ARTICLE II

DURATION

The duration of this corporation is perpetual.

ARTICLE III

PURPOSE
