* ARTICLES OF INCORPORATION *

In compliance with the requirements of F.S. Chapter 60% the undersigned, David Norman, being a natural person, does bereby act as an Incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business Corporation.

ARTICLE I

The name of the Corporation is IMAGINARY FRONTIER, INC.

ARTICLE II

The existence of the Corporation shall begin upon the filing and acceptance of these articles by the Secretary of State of the sovereign State of Florida.

ARTICLE III

The street address of the initial principal office of the corporation is located at 37 Skyline Drive, Suite 4301 Lake Mary Florida 32746. The initial mailing address of the Corporation is also 37 Skyline Drive, Suite 4301, Lake Mary, Florida 32746.

ARTICLE IV
