ARTICLES OF INCORPORATION SEMINARS UNLIMITED, INC.

THE UNDERSIGNED subscriber to these articles of incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

I

The name of this corporation shall be SEMINARS UNLIMITED, INC. and the principal place of business shall be 10604 NW 6TH STREET, PEMBROKE PINES, FL 33026.

II
