ARTICLE ONE

The name of the corporation is **RAINBOW CLEANING SERVICE, INC.** The principal address of the corporation is: 286 Racquet Club Road, #101, Fort Lauderdale, Florida 33326.

ARTICLE TWO

The period of its duration is perpetual.


ARTICLE EIGHT
