ARTICLES OF INCORPORATION OF MELIC ENTERPRISES, INC.



ARTICLE I.

1.01 Name and Address. The name of the corporation is MELIC ENTERPRISES, INC., and the mailing address of the corporation is 2259 West Howard Place, Dunnellon, Florida 34435.

ARTICLE II.

2.01 <u>Duration</u>. The period of duration of the corporation is perpetual.

- 4.02 <u>Number of Authorized Shares</u>. The aggregate number of shares that the corporation shall have authority to issue is 5,000 shares of common stock with par value of \$1.00 per share.
- 4.03 <u>Pre-Emptive Right</u>.
