#### ARTICLES OF INCORPORATION

OF

SOUTHERN STRIPPERS FLOOR CARE, INC.

The undersigned subscriber to these Articles of Incorporation, a natural person, competent to contract, hereby forms a corporation under the laws of the State of Florida.

# ARTICLE I. NAME

The name and address of the corporation is SOUTHERN STRIPPERS FLOOR CARE, INC., 12305-C 62nd Street North, Largo, FL 33773.

# ARTICLE II. NATURE OF BUSINESS

The nature of the business and the objects and purposes to be transacted, promoted and carried on are to do any and all of the things necessary to provide floor care services to both wholesale and retail establishments. In addition, this corporation may do all these things as well as all of the following as fully and to the same extent as a natural person might or could do.

- 4. To sell, manage, improve, develop, assign, transfer, convey, lease, pledge or otherwise alienate or dispose of and to mortgage or otherwise encumber land, buildings, real property, chattels, real or other property of the company, real and personal.
- 5. To issue debentures, bonds or other evidences of indebtedness secured by mortgage or mortgages upon property of this company or otherwise, and to sell the same; borrow money, make and issue its promissory notes, bonds or other evidence of indebtedness whether secured by mortgage, pledge or otherwise.
- 6. 
