The undersigned, for the purpose of forming a corporation for profit under the laws of the State of Florida, hereby adopt the following Articles of Incorporation.

ARTICLE 1

NAME

The name of this corporation is:

MD. INTERIORS, INC.

ARTICLE 2

DURATION

This corporation shall have perpetual existence unless dissolved pursuant to law and shall commence business as of the date of filing of these Articles of Incorporation.

ARTICLE 3

PURPOSE

This corporation may engage in any activity of business permitted under the laws of the State of Florida, said corporation's primary purpose is construction.

ARTICLE 4

CAPITAL STOCK

This corporation is authorized to issue 5,000 shares of no par value common stock, as follows:

ARTICLE 5

PREEMPTIVE RIGHTS






