ARTICLES OF INCORPORATION OF FLORIDA MINI ENTHUSIASTS, INC.

FILED THE SECRET SECRET

The undersigned, acting as the sole incorporator, desiring to form a corporation for profit pursuant to the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I - NAME OF CORPORATION

The name of the corporation shall be FLORIDA MINI ENTHUSIASTS, INC.

ARTICLE 11 - TERM OF EXISTENCE

The corporation shall begin its corporate existence as of the filing of these Articles of Incorporation and shall exist perpetually.
